

## **Promotion regulation "15% discount on all Unique pendant lamps"**

**Campaign period: June 1-30, 2021**

### **1. Promotion organizer**

The promotion "15% discount on all Unique pendant lamps" is organized by SC KLAUSEN EXIM SRL, based in Gilău, Farm 7, Hall 11, Cluj County, registered at the Trade Register Office under no. J12 / 5082/1994, CUI 6839312, represented by Ilka Csoregi, as General Manager, hereinafter referred to as "Organizer".

### **2. Name. Duration. Venue.**

The promotional campaign is called "15% discount on all Unique pendant lamps". The promotional campaign takes place between: June 1-30, 2021, inclusive, online on the website <https://www.uniquebyklausen.com/> and in the Unique store opened on Calea Mănăştur 38-40, in Cluj-Napoca.

### **3. Territory**

The campaign is valid for orders made on the website <https://www.uniquebyklausen.com/> and in the Unique showroom, in Cluj-Napoca, 38-40 Calea Mănăştur Street.

### **4. Promotion mechanism**

Participants in this promotion can purchase products from the pendant lamps category, of the Unique brand with a 15% discount, the organizer not assuming any responsibility resulting from the violation of these clauses. Other pendant lamps products, created by local designers, displayed in the showroom are not the subject of this campaign.

The customer cannot opt for receiving the value of the discount in cash or in other items, nor can he request changes in its characteristics / value.

The discount is not cumulated with any other promotions or facilities.

Participation in this competition includes full, express and unequivocal knowledge and acceptance of these Regulations. By participating in the Promotion is considered the automatic acceptance of the entry in the customer database of the Organizer.

### **5. Products participating in the campaign**

The object of the campaign is the pendant lamps category, available online and in the showroom, within the available stock.

The promotion will take place in accordance with the provisions of this Regulation ("Regulation").

The regulation has been drafted in accordance with the laws in force, including GO 99/2000 regarding the trading of goods and services market, republished. The regulation is mandatory for all participants.

## **6. The right and participation conditions**

Individuals over the age of 18 or legal entities from Romania can participate in the campaign, purchasing products from the Unique suspension category, online, from <https://www.uniquebyklausen.com/> or from the Unique showroom, opened in Cluj- Napoca, Calea Mănăştur 38-40, Cluj County, between 1-30 June, 2021, according to the store's operating schedule (for offline orders). The campaign is not aimed at resellers.

## **7. Protection of personal data**

Participation in the campaign implies the express acceptance of the participants for their personal data to be kept and processed by the Organizer for the purpose of potential information subsequent on his part. The organizer undertakes that personal data will not be disclosed to third parties, except for the companies involved in organizing the campaign. The participants in the campaign are guaranteed the rights provided by Law no. 677/2001 on the protection of individuals with regard to the processing of personal data and free circulation of these data, registered in the Register of Evidence of Data Processing with Personal character under number 0024423.

## **8. Disputes**

Any misunderstandings between the organizer and the participants in the promotional campaign will be resolved amicably or, if this is not possible, the disputes will be resolved by the competent Romanian courts.

## **9. Interruption of the promotional campaign**

The Organizer reserves the right to interrupt the Promotional Campaign at any time during its development, with prior information to consumers by means of proper communication (display on the site, signage in the store, etc.) By reading these Terms and Conditions you have become aware that you are guaranteed the rights provided by law, respectively the right to information, the right to access data, the right to intervene, the right to object, the right not to be subjected to an individual decision, the right to go to court in case of violation of his rights guaranteed by law 677/2001 for the protection of individuals with regard to the processing of personal data and the free movement of such data. At the same time, you have the right to object to the processing of your personal data and request their total or partial deletion.

Based on a written request, dated and signed, sent to SC KLAUSEN EXIM SRL, Gilău, Farm 7, Hall 11, you can exercise, free of charge, the following rights:

- once a year, you have to receive a confirmation regarding your personal data and if they are processed or not;
- to intervene on the transmitted data;
- to oppose the processing of data for justified and legitimate reasons related to their particular situation
- to request the deletion of data, except for the situations provided by law.

The Organizer will take all necessary measures to carry out the Campaign under normal conditions according to the above, but does not assume responsibility for complaints, appeals of participants that do not address the violation of the legal framework in force.
